#### APS BOARD ELECTIONS - VERY IMPORTANT!!

Because of the disruption caused by the global pandemic, the Alley Pond Striders did not have the opportunity to post a notice of elections and the slate of candidates nominated by the Nominating Committee. This would have normally occurred via presentation to our members followed by a membership election of the slate during our annual December Holiday Party at the Alley Pond Park Recreation Center. The Recreation Center has been off-limits to any indoor social gatherings. By our Constitution and By-Laws and under ARTICLE IV – DIRECTORS, B. ELECTION AND TERM OF DIRECTORS: "At the December meeting of the members, the membership shall elect officers/directors. Each officer/director shall hold office until the expiration of the term for which he /she was elected and until his/her successor has been elected and shall have qualified or until his/her resignation or removal."

We did post a request to the membership for nominations for all positions on the APS Board in Constant Contact on September 30<sup>th</sup> as well as in previous editions of this newsletter. However we did not receive any other nominations from the membership-at-large. Therefore to remedy this situation, an Ad Hoc meeting of the APS Board was held on Friday, January 8. As a result, this is what our Board has decided:

- The Nominating Committee was reconvened this evening in order to restart the election process for officers for the Alley Pond Striders NY, Inc. the term to begin Friday, June 11th, 2021 and ending December 31, 2021. This is being done to fulfill finding a candidate to agree to run for the office of President.
- Per Article V OFFICERS, A. Nominating Committee the Committee shall prepare a ballot of candidates for election as club officers, and to oversee the election of those candidates.
- Also and per Article V, The Nominating Committee now consists of the following three (3) Board Members VP Michael Weisbord as Chair; Walker Representative Dorothy Chusid; Social Secretary Nella Carravetta *and* three (3) Members at-large: Ken Kaiser, Lynn Henry and Ruth Mezistrano.
- Notice of Nominations to Membership will be issued no later than Sunday, May 16 via Constant Contact, the Alley Pond Website and our FB page.
- Notice of the Nomination slate of candidates will be announced and the voting process will begin on Tuesday, June 1st and end on Tuesday, June 8. Voting will be conducted electronically.
- The vote will be tallied by Membership Chair Lynn Henry and verified by Corresponding Secretary Fran Kraus-Schmidt.
- The Nominating Committee Chair will announce the newly elected Board on Friday, June 11.



#### Hi Alley Pond Striders!

As we begin yet another New Year in 2021 and despite the ongoing pandemic, we also sense hope. With vaccines now finding their way into NY, NJ and across the US - as well as around the world – we can dare to think of a return to safe and comfortable gatherings in-person. You aren't human if you don't long for human, physical contact with your family and loved ones. The simple act of greeting a good friend with a hug seems like a lifetime ago.

However, we must not let our guard down. Please continue to practice the **Three Ws**: wear a cloth mask over your nose and mouth, wait six feet apart from others, and wash your hands often or use hand sanitizer. Throughout 2020, small, in-person races were held by various race organizers, closely watched by the local government agencies to ensure compliance with safety protocols. We have even seen some races up to a half marathon distance and at least one marathon. Most events continue to be held as virtual races. Overall, the running community continues to gradually move back to more and longer racing events in 2021, the pandemic permitting.

At this writing, our Annual Alley Bowl XI (Alley Bowl Eleven) is still on schedule to be held on Super Bowl Sunday, February 7, 2021. It is subject to NYC Parks issuing us our permit to hold the event. Alley Bowl XI will also be different in

a number of safe, socially distant ways that are required, should our permit be issued. Hope also exists that we'll be able to hold our signature Five Mile (or at least, 5K) Challenge Race in April of 2021. There is more from our Runner Representative, Rob Pasqual in his column.

The actual work on Vanderbilt Motor Parkway has yet to commence but expect it to get into full swing by the spring of 2021. APS running members are still meeting at the Alley Pond Parkhouse on Tues. & Thurs. at 8:30 AM. Our Walkers are also continuing their great strides as well, thanks to our Walker Rep Dorothy Chusid and former Rep Ray Lascot. Once again, we thank NYC Parks' Matt Symons for his support and response when our members find/alert Matt to any issues inside the Park. We are fortunate to have such a fine working relationship!

Also in this issue are the results of our annual food drive in November 2020, headed by our John Sassone. It was a great success! We achieved and surpassed our goal in raising both goods and monetary donations for Sister Kathy at Our Lady of Lourdes' Food Pantry. Our own Debbie Pantano is a weekly volunteer at the OLOL Food Pantry as well. Thank you to our members in providing such generosity towards our fellow Queens resident-inneed.

The Alley Pond Striders 40<sup>th</sup> Anniversary Dinner-Dance is *tentatively* scheduled for some time in spring of 2021 at K' Pacho Restaurant. However, it appears that the holding of this important event may have to be postponed yet again. We will continue to keep you posted on the status of this event.

Finally. This last year as been socially different and difficult but please, help APS and your fellow members by continuing to pay your dues. We have been here for over 40 years, and we intend to do so for another 40...but we can't without your help and prideful support!
